# Partners undertake Big Creek Trail Alignment study through the City of Brooklyn

riends of Big Creek, Cleveland Metroparks, and the cities of Cleveland and Parma join the City of Brooklyn as co-sponsors for a \$75,000 trail alignment study funded by the federal Transportation for Livable Communities Initiative (TLCI) grant program through the Northeast Ohio Areawide Coordinating Agency. The \$60,000 grant (with a \$15,000 local match) was awarded on August 10, 2007. The City of Brooklyn will administer the grant.

The Big Creek Greenway Trail Alignment and Neighborhood Connector Plan will develop preferred alignments for a three mile all-purpose trail expansion that will connect the Metroparks Brookside Reservation to the Big Creek Reservation south of Brookpark Road. This trail alignment, first envisioned by Metroparks founder William Stinchcomb in 1916, will create a major link in the Metroparks greenway system and increase access for more than 40,000 Brooklyn, Cleveland and Parma residents and employees living or working within one mile of its route. The trail network would provide a safe alternative mode of transportation for its users and identify opportunities for interpretive exhibits and ecological restoration.

In 2004 the City of Brooklyn commissioned the Cuyahoga **County Planning Commission** to undertake a Citywide Master Plan. The plan incorporated the Planning Commission's Greenspace Plan concept of the trail expansion through the city with linkages to its neighborhoods. By 2005 the nonprofit Friends of Big Creek (FOBC) was formed to advance this concept and to act as the watershed stewardship organization for Big Creek. After a series of public meetings and deliberation with its partners, FOBC asked the City of Brooklyn to act as the administrator for the TLCI grant program.

The local match requirements

for the grant are from the cities of Brooklyn (\$4,500) Cleveland (\$2,000) and Parma (\$2,000), Cleveland Metroparks (\$6,000), and Friends of Big Creek (\$500). Other project partners include Cuyahoga County Planning Commission, Northeast Ohio Regional Sewer District, Cuyahoga River Remedial Action Plan, Cuyahoga Soil & Water Conservation District, and West Creek Preservation Committee.

The trail alignment, when combined with a potential lower Big Creek valley trail connection from the Zoo to the Towpath Trail, will enable users to access the amenities of the outer reaches of the Big Creek Parkway on one end, and the Towpath Trail and other destinations via the other. The Lower Big Creek Valley Greenway Redevelopment and Restoration Plan, currently studying the lower connection, is being administered by the Old Brooklyn Community Development Corporation. #### Parma's Evergreen Lake residents begin water quality monitoring

Between Pearl Road and Big Creek Parkway, north of Snow Road, is the charming Evergreen Lake neighborhood. In May several area residents interested in learning about good lake management practices met with Ohio State University Extension Watershed Team's Dana Oleskiewicz, and representatives from Friends of Big Creek and West Creek Preservation Committee.

Oleskiewicz introduced the Citizen Lake Awareness and Monitoring (CLAM) program sponsored by the Ohio Lake Management Society. CLAM provides an opportunity for Ohio citizens to take an active role in learning about aquatic ecology, lake and stream water quality, and watershed management. Volunteer participants document water conditions and changes, providing valuable information to state agencies and interested organizations. Oleskiewicz demonstrated monitoring procedures. CLAM lake monitors record water temperature, color, and water transparency in inches using a simple instrument called a Secchi disk. They also note climatic conditions at the time of measuring.

### Big Creek communities undertake Watershed Management Plan

The Big Creek watershed communities of Brooklyn, Parma, Parma Heights, Brook Park, and the southwest Wards of Cleveland are partnering with Friends of Big Creek and the Cuyahoga River Remedial Action Plan (RAP) to develop a comprehensive community plan for the Big Creek Watershed. Community based watershed management helps reduce flood damage, decrease the loss of greenspace, reduce soil erosion and improve water quality.

There are more than 172,000 residents in the Big Creek watershed. Water quality of Big Creek, a Cuyahoga River tributary, is the most severely impacted of the tributaries within the lower Cuyahoga River Watershed. And as recent storm events have shown, flooding can be a major problem. In 2005 Friends of Big Creek (FOBC) was formed to act as the Big Creek Watershed stewardship organization. The Cuyahoga River RAP was chosen as the organization's fiscal agent and the entity to prepare a comprehensive watershed plan for Big Creek.

The first phase of the Watershed Management Plan will enable data collection and analysis of information that will be used to identify and create a Watershed Inventory of the Big Creek Watershed and an Assessment and Problem Definition. Phase I costs are estimated at \$40,000.

In May of 2007 the RAP was awarded \$20,000. from an Ohio Coastal Management Assistance Grant that required a 50% local match. The local match was met after FOBC gained commitments from the five watershed communities making up 95% of the watershed area: Cleveland (\$6,000) Parma (\$5,000) Brooklyn \$2,500) Parma Heights (\$2,500) and Brook Park (\$2,500).

Community based watershed management helps reduce flood damage, decrease the loss of greenspace, reduce soil erosion and improve water quality.

Other project partners include Cuyahoga County Planning Commission, Northeast Ohio Areawide Coordinating Agency, Northeast Ohio Regional Sewer District, Cuyahoga Soil & Water Conservation District, Cuyahoga County Board of Health and Cleveland Metroparks.

Phase II of the plan is designed to develop a comprehensive State Endorsed Watershed Action Plan that would incorporate data and analysis developed in Phase I and also include a detailed implementation plan for improving the Big Creek Watershed. Phase II costs are estimated at \$80,000.

### Environmental inventory and assessment of Brooklyn "Oxbow" area

A t the request of Friends of Big Creek, a field inventory of the Brooklyn "Oxbow" natural area is being conducted as part of a Conservation Outreach Program at the Cleveland Museum of Natural History.

Conservation Specialist Judy Semroc has made two visits to the site to identify and document species and to conduct an environmental assessment.

On an initial visit in winter, Semroc was joined by Reneee Boronka, Associate

Director of the Center for Conservation & Biodiversity. Larry Rosche, Conservation Specialist, joined Semroc on a second visit in August.

One discovery on the summer visit was documentation of the westernmost siting of a Mocha Emerald (*Somatochlora linearis*) dragonfly and damselfly in Cuyahoga County.

A benefit of the field inventory will be advice on enhancement of native species on the property.

#### **Conserving Busch "Snake Hill" natural area**

A portion of Big Creek runs through the natural area known to locals as "Snake Hill," located behind the Busch Funeral Home on Ridge Road in Parma. The West Creek Preservation Committee (WCPC) has offered to partner with Friends of Big Creek (FOBC) to protect this environmentally significant area – 13 acres owned by the Busch Family and 47 acres owned by the City of Parma.

WCPC has spearheaded the effort to find funding that will make conservation of the area possible. This project is a onetime opportunity to permanently protect the forested natural area along upper Big Creek that could otherwise be replaced

#### **Big Creek clean-ups**

Volunteers swept through two neighborhood locations Saturday, June 9th, for the 9th Annual Big Creek Watershed Clean-Up. One group worked at Brookfield Park off West 130 which has been the clean-up site in the past. This year they were joined by a group at Archmere Park off State Road and West 41st Street, where a portion of Stickney Creek runs above ground in Cleveland's Ward 16. The event was organized by the Cuyahoga Soil and Water Conservation District.

Earlier, on May 12, members of Friends of Big Creek joined other community volunby impervious surface development. This area, when conserved, will provide new opportunities for watershed residents to experience nature close to home. The community will also benefit from the functions and services a natural area around a creek can provide, such as helping to improve water quality, slowing storm water and reducing flooding.

FOBC is excited to be working with community partners to achieve our watershed goals, and specifically look forward to working with the West Creek Preservation Committee and the City of Parma on the Snake Hill Preservation Project.

Big Creek is the 3rd largest tributary of 12, of the lower Cuyahoga River. The Big Creek watershed drains nearly 40 square miles. It comprises southwest Cleveland, Brooklyn, Linndale, Parma, Parma Heights, Brook Park, and North Royalton. It is the Cuyahoga's most severely urbanized subwatershed—52% of its surface is impervious.

Friends of Big Creek is a community-based greenway advocacy and watershed stewardship group. The Cuyahoga River Community Planning Organization, a 501(c)(3) organization, acts as the group's fiscal agent.
